DASH Pass on SmarTrip[®] Pilot Program

Overview & Participant Form

Electronic DASH Pass on SmarTrip[®] - Pilot Program Overview:

An Electronic Monthly DASH Pass Pilot will be conducted from March 1, 2011 to July 1, 2011.

An electronic pass will be loaded on a participant's SmarTrip card for use during the pilot period. There will be no additional cost to the participant to have their paper monthly DASH Pass loaded onto a SmarTrip card. Customers without SmarTrips can request a card from DASH for the pilot.

The Electronic Monthly DASH Pass will be accepted for transportation on a few other bus systems for testing purposes only and some systems may offer additional fare discounts (see table on reverse)

If the Electronic Monthly DASH Pass is used on a bus system that requires an additional fee, participants must have sufficient stored value on their card to cover the charge.

If the card is used on a bus system that does not accept the Electronic Monthly DASH Pass, the card will work as though there is no pass and you will be charged the normal fare for that trip.

If the Pilot Test is successful, testing may be extended and participants may be offered the opportunity to continue using the Electronic Monthly DASH Pass if they choose. Information will be provided to participants throughout the process.

Pilot Program Participants must agree to:

Cover all use charges and non-participant fares from their own stored value

Use the pass on a regular basis for transportation, daily or as frequently as possible, during the test period
